1. Opening of the meeting

1.1. The 16th Annual Commission Meeting was convened at the Strand Hotel, Swakopmund, Namibia, from 25th to 27th November 2019.

- 1.2. The Chairperson, Mr. Venâncio Soares Gomes, welcomed delegates to the meeting.
- 1.3. The Executive Director of the Ministry of Fisheries and Marine Resources of Namibia, Dr Moses Maurihungiriri delivered an opening address and opened the meeting officially.

2. Appointment of Rapporteur

The Secretariat was appointed as the rapporteur for the meeting.

3. Adoption of Agenda and Meeting Arrangements

The Commission adopted the agenda (Appendix I) with the following items to be added:

- Addition to Agenda item 14 <u>DOC/COM/14/2019</u> Proposal to change the Rules of Procedures of SC - submitted by Norway
- Request from the Secretariate to move item 14.3 forward on the agenda, after agenda item 7 due to the presenter from the FAO who must leave early.

The Executive Secretary introduced the submission of document <u>DOC/COM/13/2019</u> to the meeting.

4. Introduction and Admission of Observers

The Observers present represented:

- FAO Mr William Emerson
- Benguela Current Convention (BCC) Mr Xolela Wellem
- Taiyo Namibia (PTY) Ltd Mr Antonio Mansino

The Commission welcomed the participation of observers at the meeting.

5. Opening Statements by Contracting Parties and Observers

Five of the seven Contracting Parties were represented. The Republic of Korea and EU were not represented.

Contracting Parties presented their opening statements (<u>Appendix IV</u>) and introduced their respective delegates.

The list of participants is provided in Appendix II.

6. Status of the Convention in Respect of Membership

The Chairperson informed the meeting that no new notification for accession to the Convention was received during 2019 by the United Nations Food and Agriculture Organization (FAO).

7. Future Biennial Commission Meetings

The meeting discussed various aspects of having biennial physical Commission meetings with the physical meetings coinciding with the same years in which the Commission sets TAC's. Every second year, the Commission meetings should then be conducted by correspondence. Email correspondence was suggested, since not all contracting parties have fast enough internet connections to participate in live broadcasted meetings.

It was agreed by parties to test such email correspondence during 2020 when a proposal for exploratory fishing will be discussed by correspondence intersessionally.

ACTION: The meeting agreed to examine the practicalities of conducting virtual Commission meetings every second year and consider to adopt it during the 2020 Commission meeting.

8. Report of the 2019 Scientific Committee Meeting

- 8.1. The Chair of the Scientific Committee, Åge Høines (Norway), presented the 2019 SC report to the Commission (DOC/COM/03/2019).
- 8.2. Eleven Scientific Committee members from 4 Contracting Parties attended the Scientific Committee meeting. An observer from CEFAS (UK) attended the meeting.

The Commission noted that three CP's (Angola, EU and The Republic of Korea) did not attend the meeting and recalled the importance of attending SC meetings.

8.3. VME indicators recorded during 2019 Nansen Seamount Survey

The SC recommended that, given the presence of VME indicators in the Shannon and Discovery seamounts, the Commission should take precautionary action within existing fishing areas (i.e. closure for bottom trawling).

The Commission did not come to an agreement on this issue.

8.4. FarFish proposal for pilot e-logbook project (DOC/SC/14/2019).

The SC agreed that no further action is required from the Commission on this proposal from the FarFish Project.

ACTION: The Commission took note of the SC decision

8.5. FarFish request for access to SEAFO VMS data (DOC/SC/15/2019).

The SC referred the request for access to SEAFO VMS data on EU vessels active within the SEAFO CA to the Commission for further consideration.

<u>The Commission agreed that the ES should inform FarFish that no VMS data for EU vessels</u> exist in the SEAFO system.

8.6. Data request for collaboration on cold water coral habitat modeling (DOC/SC/16/2019).

The SC recommended the Commission to support the CEFAS request for access to all high-res (i.e. ship-based) bathymetry data from the SEAFO CA and collaboration between SEAFO, EAF Nansen Programme and UK.

ACTION: The Commission adopted this recommendation.

8.7. Budget 2020.

The SC recommended to keep the N\$220 000 for genetic (genomics) analysis of orange roughy samples which was allocated to the budget in 2018 for genetic analysis.

ACTION: The Commission approved the SC recommendation

9. Report of the 2019 Compliance Committee Meeting

The Chair of the Compliance Committee, Mr. Kenro Iino (Japan), presented the 2019 Compliance Committee Report to the Commission (DOC/COM/04/2019).

9.1. Annual Review of the "SYSTEM"

The CC endorsed the correction of Article 12 by changing "Tonnes per species" to "kilogram per species" and recommend to the Commission to direct to the SC to examine the proposed amendment to Article 8 (b) and (d) on the level of lost and/or abandoned gear by gear type, which would eventually cause significant adverse effect on marine living resources in the CA, so that the CC could determine relevant amendments of the SEAFO SYSTEM.

ACTION: The Commission adopted this proposal.

9.2. Consideration of the provisional SEAFO IUU Vessel list cf. SEAFO "SYSTEM"

The CC recommended to the Commission to adopt the SEAFO IUU vessel list presented in DOC/CC/05/2019 and to keep the FV Cape Flower on the list.

ACTION: The Commission adopted this recommendation.

10. Report of the 2019 Standing Committee on Administration and Finance (SCAF) Meeting

The Chair of SCAF, Mr. Hideki Moronuki (Japan), presented the 2019 SCAF Report (DOC/COM/05/2019) to the Commission.

10.1 Approval of the 2018 Draft Annual Financial Statement (AFS).

The SCAF recommended to the Commission to approve the Audited Annual Financial Statements.

ACTION: The Commission adopted the recommendation.

10.2 Staff Regulations changes to comply with the Namibian Labour Law

The SCAF adopted some changes based on the recommendations (<u>DOC/SCAF/06/2019</u>) of the labour consultant and amended the existing <u>Staff Regulations</u> and recommend to the Commission for approval.

ACTION: The Commission adopted the recommended changes

(Angola will submit the changes to the Angolan government for fulfilment of internal procedures)

10.3 Approval of the 2020 Budget and 2021 forecast Budget

The SCAF proposed the budget for 2020 of N\$ 4,159,831.23 to be approved by the Commission.

ACTION: The Commission approved the budget of N\$ 4,159,831.23.

10.4 Approval of the 2020 Contributions of Parties

Contributions by parties were calculated based on the formula adopted in 2009 and the SCAF proposed the Contributions for 2020 to be approved by the Commission.

ACTION: The Commission approved the contributions of Parties for 2020

10.5 Renewal of the three-year agreement of the current auditors.

The SCAF agreed to the reappointment of the auditors for another three-year period (2021-2023) and recommend to the Commission to adopt the proposal.

ACTION: The Commission adopted the proposal.

10.6 Review of the position of the Executive Secretary

The SCAF noted the good performance of the current ES and recommend to the Commission to extend the contract for a four-year term (Feb 2021 to end of Jan 2024).

ACTION: The Commission adopted the recommendation

11. Report back from meetings attended by the Secretariat

The following reports on meetings presented by the Executive Secretary during 2019, were submitted to the Commission and the Commission took note of them. A synthesis of each meeting was presented.

- 11.1. Areas Beyond National Jurisdiction Deep Seas Project Fourth Project Steering Committee Meeting. 23–25 January 2019, Saint Denis, Reunion (DOC/COM/06/2019).

Feedback Report on the Intergovernmental conference on an international legally binding instrument under the United Nations Convention on the Law of the Sea on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction (BBNJ). Third session, New York, 19-30 August 2019 (DOC/COM/07/2019).

The Commission took note of the reports presented by the Executive Secretary

The Commission adopted the following nominees to represent SEAFO as observers at the following meetings:

14. Any other matters

14.1 Request for IUU information of Cape Flower Chairperson SPRFMO DOC/COM/10/2019).

The Executive Secretary presented a request from Oswaldo Urrutia for access to the documentation dealing with the IUU vessel listing, FV Cape Flower, to be used in his PhD studies.

ACTION: The Commission disapproved the request to share this information due to the sensitivity of this case.

14.2 Invitation for SEAFO contributions to A BETTER WORLD Publication Ben Cornwell - Project Coordinator (DOC/COM/11/2019).

The Executive Secretary presented a request for SEAFO to act as contributor (Programme Partner) to A BETTER WORLD Vol 6, a landmark outreach book from the Human Development Forum on the conservation and sustainable use of oceans, seas and marine resources.

ACTION: The Commission approved that the Executive Secretary can write an article for the book, but no financial contribution will be made towards the project for distributing books.

14.3 Update on the ABNJ Deep Seas Project for 2019

The Coordinator of the project (Mr William Emerson) presented an update report from the ABNJ Deep Seas Project for 2019 (DOC/COM/08/2019). The Commission expresses their appreciation for the work done by the ABNJ Deep Seas Project and encourage further collaboration with SEAFO.

14.4 Proposal to change the Rules of Procedure of the SC (DOC/COM/14/2019) - Norway

The purpose of this proposal was to emphasise the role the SC plays in the decision-making process and how scientists conduct themselves within the SC meeting by functioning as a neutral scientific body, contrasting to the desires of their flag country.

ACTION: The Commission could not agree on this point and it was agreed that a draft should be prepared intersessionally to be presented to the Commission in 2020.

14.5 Additional Points

The Commission agreed to discuss another point raised by Angola.

14.5.1 Translation of documents into Portuguese.

Angola requested for the translation of all documents in Portuguese to be completed prior to the start of the meeting and all documents throughout the year be translated before they are circulated. It was noted that the Secretariate translated a huge number of documents during 2019 – both static and live documents.

ACTION: The Secretariat will continue to provide Portuguese translations in all possible situations.

15. Venue and Date of next meetings

Angola proposed to host the next annual meetings in Luanda. Norway expressed their concern regarding limited travelling budgets to cover the extra cost of travelling to Angola. Preliminary cost analysis shows that only the cost of the venue and the accompanying services to run the meetings will be 33% higher in Luanda than in Swakopmund. This excludes the additional cost of travel and accommodation costs for the Secretariat.

ACTION: The Commission agreed to consider the hosting of the meetings in Angola in future and cost analysis can be done including possible reduction of the cost by moving to biennial virtual meetings.

- Proposed dates for the 2020 Scientific Committee meeting is 16-20 November 2020.
- Proposed dates for the 2020 Annual Commission meeting (including SCAF and CC) is 23-26 November 2020.
- The venue for the 2020 Scientific and Annual Commission meetings is Swakopmund, Namibia.

16. Adoption of the 2019 Commission report

The Commission adopted the report.

17. Closure of the Meeting

The Chairperson closed the meeting at 16:45 on Wednesday 27th

November 2019 and he commended the Contracting Parties for their efficient and effective conduct during the meeting. He thanked the Secretariat for the preparations. He also thanked delegates for their positive inputs and wished everyone a safe journey back home.

Mr. Chair, Distinguished Delegates, Ladies and Gentlemen,

On behalf of the Japanese delegation, I would like to thank the Government of Namibia for hosting the 16th Annual Meeting of SEAFO with the great hospitality. I am glad to be able to come back again to this beautiful coastal city of Swakopmund. We would also like to extend our thanks to the Secretariat for their excellent preparation for this meeting.

As everyone agrees, SEAFO has been playing an important role to ensure the long-term conservation and sustainable use of the fishery resources in the Convention Area. Japan fully supports the sustainable use of marine living resources while taking account of possible impact from fisheries to ecosystem based on the scientific evidences.

In our view, one of the most crucial agendas this year is a possibility of organizing a physical Commission meeting biennially. We have been discussing this issue since 2017, and have to continue to discuss it at this meeting, including a possibility of organizing of a virtual Commission meeting in the year when the physical Commission meeting is absent. Japan requests further discussion on this important issue in order to have substantial progress taking into account the recent declining trend in the numbers of fishing vessels operating in the Convention Area and also the fact that TACs of harvested species are basically set biennially. The current situations have required us to secure the cost-effectiveness in holding the Commission meeting.

I would also like to point out that these issues arise from the recent trend observed in this organization. Activities of SEAFO Members in the Convention Area have been diminished with only a few vessels operating for a limited number of stocks. This is largely because, as Japan has repeatedly pointed out, the Convention Area has become less attractive for fishing operations due to the excessive protection of marine ecosystem and severer conservation measures. We fully recognize the importance of the conservation of fishery resources and the protection of the ecosystem surrounding them. We highly regard the concept of precautionary approach. However, there also needs an appropriate balance among the protection of the ecosystem, conservation and sustainable use of the fishery resources therein. SEAFO should provide fishermen proper opportunities for achieving conservation and sustainable use of those precious resources, through which appropriate data for relevant scientific assessment could be available for longer period.

I believe this is the right time for us to consider a way how we could properly reactivate SEAFO including through making the Convention Area much more attractive to fishermen.

With a view to promote sustainable use of the marine living resources based on scientific evidence in the SEAFO Convention Area, Japan intends to submit a notice of intent for the 2020 exploratory fisheries after this meeting. Japan would cordially ask members of the Scientific Committee and the Commission to assess the proposed exploratory fisheries during the intersessional period in accordance with the provisions of the relevant conservation and management measure. The assessment of Japan's exploratory fisheries plan will be thus conducted virtually on correspondence basis, and we believe such experience will provide us an opportunity to examine the possibility of organizing virtual Commission meetings.

Finally, I would like to conclude my remarks by hoping that we could achieve important progress toward reactivation of SEAFO as more effective organization through constructive discussions among all the participants here during this four-day meeting.
