

REPORT OF THE 16TH ANNUAL MEETING OF THE COMPLIANCE COMMITTEE (CC)

Virtual and SEAFO Secretariat Office, Swakopmund, NAMIBIA - 27 November 2023

1. Opening of the meeting

The 16th Annual Meeting of the SEAFO Compliance Committee (CC) was convened on the 27th November 2023 by Virtual means as well as four delegates attending in person at the SEAFO Secretariat Office in Swakopmund, Namibia.

The Chairperson, Mr Tae-hoon WON from the Republic of Korea, opened the meeting and welcomed the delegates.

2. Appointment of Rapporteur

The Secretariat was appointed as rapporteur for the meeting.

3. Adoption of agenda and meeting arrangements

The agenda (DOC/CC/01/2023) (Appendix I).was reviewed and adopted with one more document (DOC/CC/05/2023) added to be discussed under Agenda point 7.

4. Introduction and admission of observers

The following Observer attended the meeting and was welcomed by the Chairperson:

5. Introduction of Parties Delegations

Delegations introduced their members. See the delegate list in Appendix II.

6. Executive Secretary's Report on Compliance

The Compliance Review Report was presented by the Executive Secretary (ES) (DOC/CC/03/2023). It was noted that two fishing trip were included in the report. Changes were suggested to the report which is in red text and highlighted in yellow in the revised report (DOC/CC/03/2023/Rev 1 (27 Nov 2023). Changes were made to Table 1 as well is in paragraphs 6 and 9.1.7.

EU apologised for a little late submission of the captain logbook and commit to submitting the logbook in time in the future. The EU also thanked South Africa for the timely submission of the Port inspection report.

The ES was requested to update the TAC graphs (4a to f) with the TAC figures for future reports.

7. Annual Review of the "SEAFO System of Observation, Inspection, Compliance and Enforcement"

Japan proposed changes to the SEAFO System Article 24 (DOC/CC/05/2023). The Compliance Committee discussed the proposal with several Contracting Parties providing their inputs. Due to the time limitation, it was decided to defer the discussion to the 2024 Compliance Committee meeting. The Contracting parties were requested to submit their responses on the proposal by the end of June 2024 in writing to Japan for discussion at the 2024 Compliance Committee meeting.

8. Consideration of the provisional SEAFO IUU Vessel list for 2024

SEAFO has a joint listing agreement with NEAFC, NAFO, SIOFA and CCAMLR and the DRAFT IUU Vessel list contains the latest updates (DOC/CC/04/2023), which the CC approved and recommended that the Commission accept the SEAFO IUU vessel list for 2024.

ACTION: The CC adopted the DRAFT SEAFO IUU vessel list for 2024 and recommend to the Commission to approve the SEAFO IUU vessel list for 2024 presented in DOC/CC/04/2023.

9. Recommendations on Additional Measures of Compliance

No recommendations were made by the CC members on measures of Compliance.

10. Any Other Matters

No other matters were discussed.

11. Venue and date of next meeting

The next Compliance Committee meeting will coincide with the next Commission meeting and the date will therefore be decided by the Commission.

12. Adoption of the 2023 Compliance Committee Report

The meeting reviewed and adopted the Compliance Committee report for 2023 to be presented by the Chair to the Commission.

The Chair closed the meeting at 11:58 on the 27th November 2023 and adjourned the meeting in good faith.
