REPORT OF THE 12TH ANNUAL MEETING OF THE STANDING COMMITTEE ON ADMINISTRATION AND FINANCE (SCAF)

By Correspondence 23 – 26 November 2020

1. Opening of the meeting

The 12th Annual Meeting of the SEAFO Standing Committee on Administration and Finance (SCAF) was convened via correspondence and opened by the Chairperson, Me. Graça D'Almeida (NAMIBIA) at 11:30 (GMT+2) on 23rd November 2020.

The Chairperson opened the meeting by distributing a letter by email in which she explains how each agenda point will be addressed during the meeting.

2. Appointment of Rapporteur

The Secretariat was confirmed as rapporteur.

3. Adoption of agenda and meeting arrangements

The agenda was reviewed and adopted with no amendments (Appendix I).

The Chairperson explained that the meeting will mainly be conducted by email but also by use of Google Docs where possible. She emphasised that feedback from all Parties are important and especially when adopting the Parties' contribution for 2021.

4. Introduction of Parties' Delegations

The list of attendance can be seen in (<u>Appendix II</u>).

5. Presentation of the 2019 Audit Report

The 2019 audit report (<u>DOC/SCAF/03/2020</u>) and the Report to Management from the Auditors (<u>DOC/SCAF/04/2020</u>) were available for comments from participants

SCAF noted the auditor's opinion that the financial statements present fairly, in all material respects, the financial position of SEAFO as at 31 December 2019, and its financial performance and cash flows for the year then ended in accordance with the basis of accounting. The auditors further reported that the audit evidence they have obtained is enough and appropriate to provide a basis for their opinion.

The auditor's Report for Management contained no comments from the auditors.

ACTION: The Audited Financial Statements for the 2019 financial year was endorsed by the SCAF and recommends to the Commission to approve it.

6. Presentation of the Executive Secretary's Report on Administration and Finance

The Executive Secretary's report on Administration and Finance (DOC/SCAF/05/2020) covering the period from January 2020 to end of September 2020 was available for questions and comments by participants.

The Executive Secretary reported that only three Contracting Parties made their contributions at the time of the compilation of the 2020 report. The ES informed the meeting that part of the outstanding contribution of Namibia was received after the compilation of the report. The other outstanding Contracting Parties confirmed that their payments will be done soonest and before the end of January 2021.

SCAF expressed satisfaction with the report presented by the Secretariat

7. Approval of the 2020 Provisional Budget and 2021 forecast Budget

The 2021 provisional and the forecast budget for 2022 and the explanatory notes (DOC/SCAF/07/2020) & (DOC/SCAF/06/2020) was available for participants for questions and comments.

The overall proposed budget for 2021 (<u>Appendix III</u>) is N\$ 3,957,541.52, which is a 4.86 % decrease from the allocated budget for 2020 of N\$ 4,159,831.23

ACTION: The SCAF agreed to propose the budget to the Commission for approval.

8. Contributions by Parties

Contributions by parties were calculated based on the formula adopted in 2009 (Appendix V).

ACTION: The SCAF agreed to propose the Contributions to the Commission for approval.

9. Adoption of the SCAF Report

SCAF reviewed and adopted the report to be presented by the Chair to the Commission.

10. Closure of meetings

The Chairperson closed the meeting at 09:30 on 26th Nov 2020. She thanked the delegates for their support and cooperation.
